A regularly scheduled meeting of the West Fargo School Board, West Fargo Public School District #6, pursuant to due calls and notice, was held at the Leidal Education Center Boardroom on November 14, 2022, at 6:00 PM, with President Patti Stedman presiding.

Members present included President Patti Stedman, Vice President Jessica Jackson directors, Jon Erickson, Trisha Page, Dan Schaeffer, and Jessica Jones. Also present, representing the school district was Superintendent Beth Slette, Assistant Superintendent of Secondary Curriculum and Instruction Vincent Williams, Assistant Superintendent of Elementary Curriculum and Instruction Rachael Agre, Business Manager Levi Bachmeier, Director of Human Resources Brittnee Nikle, and Board Secretary Alicia Severson. Director Jim Jonas and Director of Technology Ed Mitchell were absent.

Mr. Schaeffer moved, seconded by Mr. Erickson, to adopt the agenda. The motion carried unanimously.

David Schneck, Aurora Elementary Principal; Chris Kalsow, Westside Elementary Principal and Nikki Weltin District Curriculum Coordinator were in attendance to present to the board about WFPS Elementary ELA Curriculum. Dan Holder, Liberty Middle School Principal and Erin Petersen, District Curriculum Coordinator were in attendance to present to the board about WFPS middle school social studies curriculum.

Ms. Page moved, seconded by Ms. Jackson, to accept find the administration making reasonable progress with noted exceptions regarding Board Policy DR 2.1 ELA. Exceptions found on DR 2.1 indicator 6 and 10. The motion carried unanimously.

Ms. Jackson moved, seconded by Mr. Erickson, to accept find the administration making reasonable progress regarding Board Policy DR 2.1 ELA. The motion carried unanimously.

Mr. Schaeffer moved, seconded by Ms. Jackson, to accept find the administration in compliance regarding Board Policy OE 12 2 Facilities. The motion carried unanimously.

There was a committee report from the Governance Committee.

Mr. Schaeffer moved, seconded by Ms. Page, to approve the consent agenda which consisted of minutes from the regular meeting of the school board held on October 24, 2022; one resignation; a contract with MBN Engineering, Martin Mechanical, YHR Partners for flooring plans and specs, YHR Partners for roofing plans and specs, and a set of bills (please see the attached bill list). The motion carried unanimously.

During the president's prerogatives, the school board discussed current issues and future opportunities.

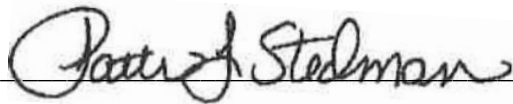
The meeting adjourned at 7:58 PM.
